Investigation No. 553 into alleged dumping and subsidisation

Fourth extension of time granted to issue the Final Report

Customs Act 1901 - Part XVB

On 27 May 2020, the previous Commissioner of the Anti-Dumping Commission published a notice announcing the initiation of an investigation into the alleged dumping and subsidisation of painted steel strapping (the goods) exported to Australia from the People's Republic of China and the Socialist Republic of Vietnam.

A full description of the goods is available in Anti-Dumping Notice (ADN) No. 2020/050 (the initiation notice) on the Anti-Dumping Commission's (Commission) website at www.adcommission.gov.au.

The initiation notice advised that a recommendation to the Minister for Industry, Science and Technology (the Minister) would be made in a final report, on or before, 29 October 2020.

The time period for providing the final report and recommendation to the Minister was extended.¹ The current due date is 15 June 2021.

On 23 April 2021, Dr Bradley Armstrong PSM, the Commissioner for the Anti-Dumping Commission (the Commissioner), published a statement of essential facts (SEF)² in relation to this investigation.³ The legislated deadline for submissions (13 May 2021) to the SEF has expired.

The Commissioner has received four submissions to the SEF.⁴ In order to allow the Commission time to consider the submissions made in response the SEF, I, Paul Sexton, General Manager of the Investigations Branch of the Anti-Dumping

Commission, requested a further extension of time to provide the final report and recommendation to the Minister.⁵

The Commissioner has, under section 269ZHI(3) of the *Customs Act* 1901,⁶ approved the request for a further extension.⁷ A recommendation to the Minister will now be made in a report due on, or before **Friday**, **13 August 2021**. The extension of time has not been granted to allow further submissions to the investigation.⁸
